Pursuant to Regulation 30 read with Schedule III of the SEBI Listing Regulations and in furtherance of our earlier intimation dated August 29, 2025 regarding the purchase of an industrial property (Factory Land and Building) at Gomta, Rajkot, we wish to inform you that the Board of Directors of Jigar Cables Limited ("the Company"), at its meeting held on December 31, 2025, has considered and approved the setting up of a new manufacturing facility/unit at the said location and the commencement of manufacturing of Medium Voltage Control Cables, High Tension (HT) Cables and Power and Control Cables (PCC) at the said facility.

The establishment of the new manufacturing facility and the proposed expansion of the product portfolio are aimed at strengthening the Company's manufacturing capabilities, catering to evolving market demand, and supporting future growth.

The commercial production from the new facility is expected to commence within the next one to three months, subject to completion of installation and trial runs.

The installed capacity for the new products at the proposed facility is expected to be 500 KM per month, which will be utilized progressively based on market demand.
